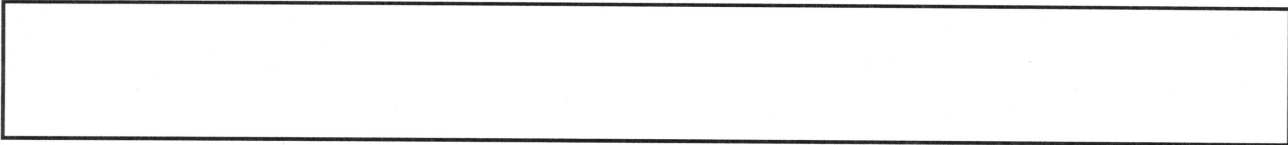

A full field investigation was conducted concerning applicant in 1953 under Executive Order 10422 (United Nations Loyalty Program) and reports were disseminated to Civil Service Commission (CSC). Investigation was discontinued upon receipt of information that Dr. Frazier was no longer employed by UNESCO. CSC has now advised that Dr. Frazier is being reconsidered for UNESCO employment and has requested that previous investigation be brought up to date. Conduct supplemental investigation in accordance with CSC's request. Office files including reports of previous investigation should be thoroughly reviewed to insure that all logical leads are covered and all pertinent information is reported. Office files should also be checked concerning applicant's immediate relatives by offices covering their places of residence. WFO will also make up-to-date agency checks.

Enclosed for each office is copy of applicant's ILB-2 form.

Dombrowski, Executive Director, SCEF, before Senate Internal Security Subcommittee in March, 1954. This testimony (page 32) showed that Frazier was member of Board of Directors of SCEF. Numerous reports submitted by New Orleans Office show Frazier has been affiliated with SCEF for number of years. Enclosed with WFO letter of 8/29/58 were copies of undated open letter to House of Representatives which included name of E. Franklin Frazier. New Orleans report of 9/18/58 disclosed that Frazier was among signers of open letter to House of Representatives urging HCUA to stay out of the South. (100-10355-535, 735, 744)

New York report of 7/15/53 entitled "World Peace Council . . . , IS-C," New York file 100-94580, shows that the "Worker" of 10/15/50, page 4, contains item in which Dr. E. Franklin Frazier was listed among initial sponsors of a group which called itself "Defenders of Peace from Prague." (100-361031-445)

Enclosed with New York letter of 9/13/55 entitled "Israel Lublin, IS-C," (cc WFO) New York file 100-98199, WFO file 100-13330, was copy of letter dated 11/15/54 indicating Dr. Frazier attended meeting sponsored by Civil Rights Congress (CRC), Council on African Affairs, etc., on 10/13/49 at Turner's Arena. Page 6 of New York report of 5/18/56, and page 10 of New York report of 8/31/55 entitled "National Committee to Repeal the McCarran Act (NCRMA), IS-C," New York file 100-102245, show that applicant was listed among initiators and members of the Planning Committee of the NCRMA. (100-376056-46, 53)

C., was among signers of a Statement of Principles for the Defense of Democracy which included a statement urging reinstatement of teachers dismissed because of actual or alleged CP membership. Chicago letter of 3/2/60 (cc New York) entitled "CPUSA . . . , IS-C," Chicago file 100-33737, shows that a document entitled "A Marxist Quarterly Review of the Negro Liberation Struggle - Prospectus," was in possession of top CP officials and consideration was being given by top CP leaders for a Negro Marxist quarterly magazine. E. Franklin Frazier was listed in the Prospectus among contributing editors. Chicago Office noted that utmost care should be used in handling this information to protect highly placed informant. Chicago Office is requested to furnish its views to Bureau with regard to disseminating this information, appropriately paraphrased, to CSC for consideration in this case. 

In 1953 an investigation under Executive Order 10422 (UN Loyalty Program) was initiated when he was employed by UNESCO and terminated in September, 1953, when information was received he had left UNESCO. A supplemental investigation is being initiated at CSC's request as Frazier is now being considered for additional UNESCO employment. Previous investigations show he has been affiliated as member, sponsor, supporter, speaker, or signer of communications in behalf of fifteen organizations designated under Executive Order 10450 and seven organizations cited by congressional committees as communist fronts.

✓ "The Southern Patriot," official publication of the Southern Conference Educational Fund, Inc. (SCEF), issue of April, 1954, on page 4, published an article under the caption "Negro Leaders Send Protest to Jenner." The article reported that thirty-three Negro leaders from fifteen Southern states and the District of Columbia sent an open letter to Senator WILLIAM E. JENNER condemning his attack on the Southern Conference Educational Fund as "an attack upon the Negro community of this Nation." Among the signers was listed "E. FRANKLIN FRAZIER, Washington, D. C." (See Exhibit A)

The March 11, 1954, issue of the "New Orleans Times-Picayune," under the caption "Seven Subpoenaed in Probe of Southern Organization," published a list of officers and members of the Board of Directors of the SCEF as furnished by JAMES A. DOMBROWSKI, Executive Director of the Fund. Among the members of the Board of Directors was listed "E. FRANKLIN FRAZIER, Professor of Sociology, Howard University, Washington, D. C."

[redacted] made available a letterhead of the SCEF on August 11, 1954. On the reverse side of the letterhead was printed the names of the officers and members of the Board of Directors of the SCEF. Under the heading "Board of Directors," was listed "Dr. E. FRANKLIN FRAZIER, Washington, D. C."

b7D On August 18, 1955, [redacted] provided a letterhead of the SCEF, the reverse side of which contained a list of the officers and members of the Board of Directors. "Dr. E. FRANKLIN FRAZIER, Washington, D. C.," was named as a member of the Board of Directors.
