On June 24 and 25, 1944, the Illinois Midwest Negro People's Assembly held a conference in Chicago. Louise Thompson Patterson attended and spoke briefly, stating that the conference was launching a program that would unify Negroes with all groups that were progressive Americans to make Democracy work. During the conference, Patterson was appointed to the Credentials Committee. She was also appointed to the Continuations Committee which was to hold meetings every night during the Democratic Convention (date and place not stated) asking Negro delegates to attend the meetings and form a working agreement to try to inject some of the assembly's principles into the Convention.

Patterson was planning a large city-wide IWO meeting in connection with Negro History Week. She was anxious to properly dovetail the IWO meeting with other CP activities. She was arranging a special seven weeks extension course class for lodge members in cooperation with the Abraham Lincoln School. Louise attended 12/14/45 Lodge meeting, during which it was announced that the Lodge had 2000 adult and 500 children members. Patterson was elected executive secretary of the South Side Citizens Committee to aid the Packinghouse Strikers, and was to use her influence to guide the Committee's activities. She was arranging to have Paul Robeson, Negro singer, to speak at a Committee mass meeting on 1/20/46. Patterson was to speak at a meeting of the United Shoe Workers - CIO on her experiences in Russia, as well as the role of the Negro worker in America.

Patterson were still in Chicago.
