ReNYlet, 6/15/60, captioned as above, reporting that LOUISE PATTERSON and [redacted] would leave for the Soviet Union "in a week or so," and that WILLIAM PATTERSON was discussing with the Soviets the possibility of [redacted] the Friendship of the People's University in Moscow.

On 6/20/60, [redacted] advised SA [redacted] that on 6/17/60, he conferred with [redacted] CP, USA [redacted] who told him the following:

LOUISE PATTERSON and [redacted] will leave NYC for the Soviet Union on June 30th. ([redacted] did not specify how they would travel). [redacted] will attend college either in Moscow or Prague. It is quite likely that WILLIAM PATTERSON will retire as a CP functionary, and engage in public relations work in Prague, probably in connection with some tourist agency.

[redacted] further stated that [redacted] [redacted] as previously reported by [redacted] a [redacted] will leave soon for Moscow, where she will study at a conservatory of music during the coming summer months. She will return to the USA in the Fall. She already has a visa, and will go to Paris, where arrangements will be made by the Soviets for her to go to Moscow.

[redacted] said that it was ascertained that she is too young to attend the Friendship of the People's University, but that she may be eligible to attend the said school next year.

NOTE ON YELLOW:

Subject is wife of William L. Patterson chairman New York District CPUSA. She is apparently going to visit [redacted] who is attending school in the USSR. Subject was a member or official of numerous Communist Party (CP) fronts between the early 1930's and 1955. In 1947 she was Vice-President of the IWO. She attended the 40th anniversary celebration of the CPUSA in 1959 and attended the 1-21-61 session of the National Committee meeting of the CPUSA. As of April, 1961, she was assigned to the Sixth AD Club of the Kings County CP. There has been located no evidence of CP membership subsequent to 10-20-61, the date the passport sanction of the ISA-50 became effective. Subject's name is included in SI and a current report is in preparation. Copies of all pertinent reports have been furnished State and CIA.

STRONG Memorial Educational Trust Fund was to be held at subject's residence in May, 1959; received invitation to special preview of USSR exhibition that was in New York, New York, in June, 1959; to join her husband, WILLIAM L. PATTERSON, in Europe in June, 1960.

DETAILS:

I. BACKGROUND

A. Residence

On June 6, 1960, [redacted] [redacted] Brooklyn, New York, advised that LOUISE PATTERSON resides at 1258 President Street, Brooklyn, New York.

B. Employment

On June 6, 1960, by means of a suitable pretext by a Special Agent of the Federal Bureau of Investigation (FBI) it was determined that LOUISE PATTERSON was employed by the Foundation for Cooperative Housing, 31 Union Square West, New York, New York.

II. AFFILIATION WITH THE COMMUNIST MOVEMENT

The Communist Party (CP), USA has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The CP, USA New York District is commonly referred to as the New York State CP.

[redacted] advised on October 8, 1959, that LOUISE PATTERSON was in attendance with her husband, WILLIAM L. PATTERSON, at the 40th Anniversary Celebration of the CP, USA held September 25, 1959, at Carnegie Hall, New York, New York.

[redacted] related that at this meeting various CP functionaries spoke including ELIZABETH GURLEY FLYNN and BENJAMIN J. DAVIS, Jr.

[redacted] stated that ELIZABETH GURLEY FLYNN delivered the introductory address and that BENJAMIN J. DAVIS, Jr. discussed the question of integration throughout the United States.

"The Worker", January 31, 1960, page 16 identified WILLIAM L. PATTERSON as Vice-Chairman of the New York State CP.

On December 14, 1959, [redacted] advised that at the 17th National Convention of the CP, USA, ELIZABETH GURLEY FLYNN was elected to the National Committee of the CP, USA.

"The Worker", February 21, 1960, page 1, identified BENJAMIN J. DAVIS, Jr. as National Secretary of the CP, USA.

"The Worker" is an East Coast Communist weekly newspaper.

[redacted] advised on May 27, 1959, that on that date, BENJAMIN J. DAVIS, Jr. talked with LOUISE PATTERSON and discussed the possibility of working out a discussion concerning the CP Amnesty Campaign.

[redacted] advised on May 4, 1959, that a meeting was to be held on May 21, 1959, at the residence of LOUISE PATTERSON for the purpose of expanding the EDWARD E. STRONG Memorial Educational Trust Fund before the summer vacations start.

A characterization of the EDWARD E. STRONG Memorial Educational Trust Fund appears in the Appendix of this report.

[redacted] related on June 23, 1959, that [redacted] of the USSR Exhibition, New York, New York, had advised that an invitation was sent to Mr. and Mrs. WILLIAM L. PATTERSON, 1268 President Street, Brooklyn, New York, to attend a special preview of the USSR Exhibition on June 29, 1959. This exhibition was scheduled to be held from June 30, 1959 through August 10, 1959, at the New York Coliseum, New York, New York.

[redacted] stated on August 17, 1959, that [redacted] stated that among others Mr. and Mrs. WILLIAM L. PATTERSON, 409 Edgecombe Avenue, New York, New York, was sent an invitation to attend a press conference and cocktail party on August 7, 1959, in connection with the closing of the USSR Exhibition at the New York Coliseum.

During the period from 1952 through 1955, LOUISE PATTERSON resided at 409 Edgecombe Avenue, New York, New York.

Proposed Foreign Travel

[redacted] advised on February 1, 1960, that on January 27, 1960, WILLIAM L. PATTERSON stated that he and his wife, LOUISE PATTERSON, plan to leave the United States for Czechoslovakia at the end of February or the first part of March, 1960.

[redacted] advised on February 27, 1960, that during the week of February 21, 1960, WILLIAM L. PATTERSON had stated that he would leave the United States for Czechoslovakia on March 13, 1960. PATTERSON further stated that his wife, LOUISE PATTERSON, would join him in Europe in June, 1960.

The records of the Passport Office, Department of State, Washington, D.C., were reviewed on February 10, 1960, by SA [redacted]. These records reflect that on January 5, 1960, LOUISE PATTERSON was issued a Passport, Number 1822449. PATTERSON, on her Passport Application, dated January 5, 1960, and executed at the Department of State, New York, New York, advised that she contemplated departing from the United States approximately January 20, 1960, for a one month vacation trip to England, France and Czechoslovakia. b7C

PATTERSON's Passport File further reflected that as of June 6, 1932, she was issued a Passport, Number 516630, for travel to Germany. The Passport was issued under the name LOUISE THOMPSON, and that the purpose of the trip was to study. She indicated that she would return to the United States in two years.

PATTERSON's Passport File also reflects that she was issued a Passport, Number 468381, on August 5, 1937, under the name LOUISE THOMPSON. At this time, the subject advised that the Passport was desired for travel to France, England and Spain.

On June 17, 1960, [redacted] Trans World Airlines (TWA) advised that Miss LOUISE PATTERSON, 1268 President Street, Brooklyn, New York, had made reservations on Flight 802, TWA, leaving International Airport, Queens, New York, at 10:00 p.m. on June 30, 1960, for Paris, France.

### III. MISCELLANEOUS

The records of the Bureau of Special Services, New York City Police Department, as caused to be searched on June 1, 1960, by SA [redacted] reflected no current information regarding LOUISE PATTERSON.

The records of the Credit Bureau of Greater New York were furnished by [redacted] to IC [redacted] on June 3, 1960, and contained no information of a derogatory nature concerning PATTERSON.

Other informants familiar with certain phases of CP activity in the New York City area advised during June, 1960, that they could furnish no current information concerning CP activity on the part of PATTERSON.

EDWARD E. STRONG MEMORIAL  
EDUCATIONAL TRUST FUND

On April 19, 1957, a confidential source advised that on that date he observed a telegram addressed to Room 710, 250 South Broad Street, Philadelphia, Pennsylvania, headquarters of the Communist Party (CP) of Eastern Pennsylvania and Delaware. The telegram announced the death of comrade EDWARD E. STRONG on April 10, 1957. It also urged that expressions of sympathy should take the form of generous contributions to a Memorial Educational Fund for the education and care of **STRONG**'s children. The telegram was signed by "The National Committee, CP, USA".

The CP, USA has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

On September 17, 1957, another confidential source made available a four page pamphlet announcing the establishment of the EDWARD E. STRONG Memorial Educational Trust Fund. The pamphlet reflects that in "1949, EDWARD STRONG assumed the post of Chairman of the CP of Eastern Pennsylvania. He became a member of the National Committee of the CP and served that organization in various capacities until his death."

The pamphlet reflects the trustees of the Fund are HERBERT APTHEKER and Dr. W. ALPHAEUS HUNTON.

On July 14, 1954, HERBERT APTHEKER testified in a Smith Act case in the U.S. District Court, Eastern District of Pennsylvania, that he was, at that time, a CP member and that he had been a member since 1939.

On June 20, 1950, another confidential source advised that he knew ALPHAEUS HUNTON as a concealed CP member as late as 1945 and that HUNTON revealed himself as a thorough Communist.

On May 20, 1958, a confidential source advised that a trust savings account had been opened on June 28, 1957, in a Brooklyn bank in the name of HERBERT APTHEKER and W. ALPHIAEUS HUNTON. The address for the fund account is the home address of APTHEKER, 32 Ludlam Place, Brooklyn, New York. The above source advised in April, 1959, that the Fund remains at the same location with the same Trustees.

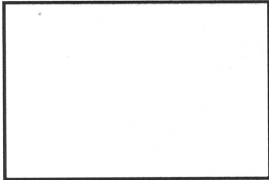

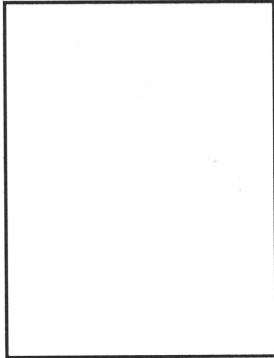

A confidential source recently advised that Louise Patterson had been granted permission by the Communist Party, USA, to go to the Soviet Union to visit [redacted] who resides in that country. Patterson will leave the United States on July 1, 1962, for the Soviet Union. Patterson, at the time of her departure, will be traveling on United States Passport number 1822449. b7C

Background:

Louise Patterson is the wife of William L. Patterson, Chairman of the New York District, CP, USA. She was born September 9, 1901, in Chicago, Illinois, and attended the University of California at Berkeley, California. Patterson visited Russia in 1932 or 1933, and toured Loyalist Spain in 1937. Patterson was a member of the Central Committee of District Number 8, CP, USA, in 1945, and a member of the Harlem Region, New York County CP as of June, 1955. Between the early 1930's and 1955 she was active as a member and/or official of numerous CP front groups. In 1947, she was elected Vice-President of the International Workers Order, an organization designated by the Attorney General of the United States pursuant to Executive Order 10450, and was active in that organization until its dissolution in 1954. In May, 1958, she was Chairman of an affair to raise funds for the children of a deceased CP functionary. Patterson was in attendance at the 40th Anniversary celebration of the CP, USA, in 1959. Patterson traveled to the Soviet Union in 1960. She was in attendance at the January 21, 1961, session of a three-day National Committee meeting of the CP, USA. Patterson was assigned to the 6th A.D. Club of the Kings County CP in April, 1961.

Louise Patterson is described as a Negro female, 61 years of age, five feet two inches, 130 pounds, black graying hair, and brown eyes.

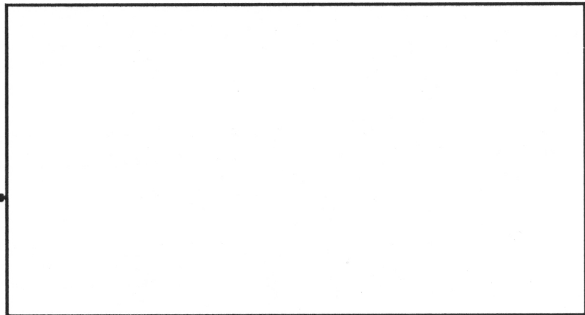

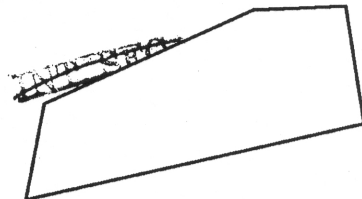
