At the 17th national convention of the CP, USA, which ended on 12/13/59, 60 functionaries were elected to the new national committee of the Party. [redacted] the former members were not re-elected. The intensified investigation of these [redacted] individuals under the Internal Security Act of 1950 should, therefore, be immediately discontinued and future reports and correspondence should no longer include "Internal Security Act of 1950" in the character of the case. (u)

The mere fact of failure to be re-elected to the national committee does not, however, automatically justify the deleting of these individuals from the top functionary or key figure lists. Requests to so delete, if justified, should be submitted to the Bureau by separate communication in the individual case. (u)

He was born in Minnesota in 1913 and has a BSS from CCNY. Brown is a former leader of the YCL and formerly employed in an editorial post with "New Masses" and "Masses" and "Mainstream." He was on the national committee, CP, USA, as a result of the 16th National Convention, but he was not re-elected at the 17th in December, 1959. According to New York, he is relatively inactive in CP activities. Attempts have been made to approach Brown with security with negative results and it is felt New York should have additional authority to make this approach when possible.

(An attempt was made to approach him under the Toplev Program in 1959, but such could not be done with security and efforts were terminated. It is felt that New York should make another attempt to approach Brown.)

On 2/20/62, in the vicinity of 43rd St. and Broadway, NYC, LLOYD BROWN was approached by SAS [redacted] and [redacted] for the purpose of conducting an interview under outstanding instructions relating to the Toplev Program **(u)**

When approached BROWN acknowledged his identity whereupon the Agents identified themselves and suggested to BROWN that he pause momentarily to discuss certain matters of apparent mutual interest. **(u)**

BROWN, in an excited and vehement manner, stated that he was only interested in his freedom and that he was not going to discuss anything with the FBI until he got his freedom. Continuing, he stated that the FBI should be down south investigating the deplorable conditions under which the negroes must live. **(u)**

When pressed for a specific situation wherein the Bureau would have jurisdiction, BROWN, unable to state one, continued a tirade concerning his freedom. When it was mentioned to BROWN that he could hardly deny that great strides had been made in the Negro question, and, that since he apparently did not think so, it should then follow that his activity in the communist movement was ineffective, and, therefore, perhaps he would listen at least to the interviewing Agents who could suggest a new approach to him. **(u)**

BROWN ignored this conversation and stated, "I'm just a Mau-Mau without a spear. Go ahead, call me a 'nigger' everybody else does." BROWN continued by advising the Agents to go back and tell whoever they tell that he is the meanest, rottenest s-- o- b---- they ever met and that is the way he is going to be until he gets his freedom. (S) u

Further efforts were made to bring BROWN around to discussing himself and the communist conspiracy, and, to neutralize by reason, his apparent obsession with lack of freedom because he was negro. (S) u

BROWN ignored all these efforts and continued ranting in an irrational manner. The interview was thus terminated. (S) u

In view of BROWN's hostile attitude coupled with his expressed obsession with negro inequality, no recontact is contemplated at this time. The results of this interview will be contained in the next report submitted on the subject. (S) u
