FREEDOMWAYS ASSOCIATES, INC.

The records of the New York Secretary of State, Albany, New York, show that the certificate of incorporation of Freedomways Associates, Incorporated, was filed on March 2, 1961.

The Spring, 1963, issue of "Freedomways" is self-described as "A Quarterly Review of the Negro Freedom Movement" published by Freedomways Associates, Incorporated, 799 Broadway, New York City.

On May 24, 1961, a source advised that a report was given on "Freedomways" at a meeting of the National Board, Communist Party, USA (CPUSA), held on May 24, 1961. It was stated that the original plan called for the publication to be openly Marxist, but that it was later decided it would not be avowedly a Marxist publication. Editorials are in the hands of a mixed group of Marxists and non-Marxists. It was stated that the central purpose of "Freedomways" is to develop a theory and positive criticism of currents in the Negro movement, as well as to raise the level of understanding and discussion taking place in Negro life today and to project a socialist and pro-Soviet orientation.

On May 25, 1961, another source advised that "Freedomways" was set up for the CPUSA by James Jackson, a member of the National Committee of the CPUSA.

The above sources have furnished reliable information in the past.

[redacted] also mentioned that [redacted] needed help on the affair that [redacted] was promoting and asked O'DELL to help. He said he would try to see her that day, but had to go to the AFL-CIO convention where "We're pushing Freedomways there". He added "I know a few of those guys. The packinghouse boys bought quite a few yesterday". He said that he was covering that yesterday and today. (X)u

According to [redacted] (ph) contacted O'DELL on 11/19/63, and stated that she was looking for him the previous day. O'DELL said that he was tied up at the AFL-CIO convention and had to go over there for "Freedomways". [redacted] asked him to stop by the office that day and O'DELL said he would be there around noon. (X)u b7C-2

According to the informant, [redacted] also contacted O'DELL and reminded him that they were supposed to meet with someone at the office that day at 10:00 a.m. She referred to this person as "that man on promotion" and also said that he was the guy who had been in and had done some promoting for the "United Negro College Fund". O'DELL stated that he would be there in a half hour. (X)u

Subsequently on the same date, [redacted] tried to contact O'DELL, but O'DELL was not available. She said she was supposed to see O'DELL later. (X)u

According to [redacted] attempted to contact O'DELL on the evening of 11/19/63, stating that she had spent hours awaiting to see CLARENCE JONES whom she didn't get to see, but that while she was there O'DELL came by the office but left. She said that she wanted to see both of them. (X)u

On 11/20/63, [redacted] Manhattan Center, 311 West 34th St., NYC, advised that the Association of Artists for Freedom had contracted to rent that center for a show and rally at 8:00 p.m. on 12/11/63. She said that the contract was arranged by Mrs. GRACE KILLENS, 15 East 40th St., NYC, NY 6-0530. (u)

Subsequently on 11/20/63, [REDACTED] Manhattan Center, advised that GRACE KILLENS had called him and cancelled the reservation for the night of December 11, stating that she did not have enough time to get out the publicity and to have artists available. [REDACTED] stated that his few contacts had been with Mrs. KILLENS and that he never heard of an O'DELL. He said that Mrs. KILLENS stated that her group was a new organization and that it appeared to him that she was also shouldering the burden for everything.

At 4:40 PM, 12/9/63, Inspector J. A. SIZOO called from the Bureau and instructed the NYO to immediately prepare an investigative report, suitable for dissemination, on the captioned individual. BALDWIN is the well-known Negro author and during recent months has been active in certain integration activities.

Mr. SIZOO said that sometime during recent months BALDWIN is reported to have made a statement to the effect that he would not fight for this country. The fact that BALDWIN made such a statement has come to the attention of the Attorney General.

Mr. SIZOO said that at the time we submit this report to the Bureau, we should also submit our recommendation for including BALDWIN on either the Security Index or the Reserve Index. Mr. SIZOO said that in the event the NYO does not feel we can justify recommending him for the Security Index, we should at least recommend him for the Reserve Index as the Bureau definitely feels this action is warranted on the basis of information presently available concerning BALDWIN.

Mr. SIZOO instructed that this report be submitted not later than 12/11/63.

"He outlined the NCAHUAC strategy for the period between now and January 1965, during which the appropriation for HUAC will come up in January 1964. It is apparent, he said, that the HUAC will press for more and more legislation based on the McCarran ACT. (X)u

"The National Committee will prepare reprints of an article by HENRY STEELE COMMANGER which appeared in the New York Times, on the First Amendment right of travel. The new National pamphlet will document the fact that the HUAC is led by segregationists, and racists, and harries people who are working for integration. (X)u

"The Secretary described a meeting at American University, in Washington, D.C. during which 15 fights and arrests took place, and when the Secretary was physically attacked on the platform. The students had an opportunity to see the danger of fascism in action, but the actions of the Nazis in breaking up the meeting resulted in a decision to close future meetings at the University to the public. (X)u

"The numerous meetings at other colleges and universities were successful, although ultra-rightists and Bircher elements were well represented. The many rough questions were successfully handled by the Secretary, as evidenced by student applause, and invitations to return to speak at future meetings. (X)u

"The Secretary feels that attitudes are changing around the country, but that it will be impossible to have integration and civil liberties until the HUAC is abolished. (X)u



The "Guide to Subversive Organizations", revised, December 1, 1961, pp.43-44, describes this committee as follows:

"The Citizens Committee to Preserve American Freedoms \* \* \* specializes in propaganda aimed at abolishing the Committee on Un-American Activities and discrediting the Federal Bureau of Investigation. Created in Los Angeles in 1952, the front organization is run by FRANK WILKINSON, an identified Communist who recently resumed the full-time, paid post of executive secretary after approximately a year's leave of absence to assist in a similar campaign by another front in New York City, the Emergency Civil Liberties Committee.

"When the Committee on Un-American Activities held hearings in Los Angeles, September 2-5, 1958, to inquire into the nature of the Party's recent reorganization in California, the Citizens Committee to Preserve American Freedoms sponsored a series of public meetings to protest the hearings and the very existence of the Committee. Communists subpoenaed as witnesses were guests of honor.

"At this time, leaders of the party's Southern California District, were mobilizing Communists in the area for participation in an intensified campaign to abolish this committee of Congress. How the Citizens Committee to Preserve American Freedoms served the party in this effort was revealed by (Communist Party) District Chairman DOROTHY HEALEY in a report to the party's Southern California District Council on September 21, 1958. Mrs. HEALEY declared that the party preferred public protest meetings to be held by the Citizens Committee to Preserve American Freedoms rather than under party auspices because Communists could attend without danger of being exposed as members of the party. She also noted that Communists scheduled as congressional committee witnesses could not appear beforehand at openly Communist rallies without creating the impression that the party was conspiring with witnesses to withhold information from the committee."

On December 2, 1963, there was received through a confidential mail box of the NYO a flyer from Freedomways Associates containing pictures of the front and back covers of "Freedomways" issues for the Summer and Fall of 1963. This flyer states that the magazine is "a quality journal of fact-filled articles by outstanding Negro scholars, poets and artists on topical questions of the Negro freedom movement. Analyzes and critically evaluates programs and status of the Negroes in the United States, the African peoples, and peoples of color in Latin America." This flyer requests that gift subscriptions be given to "Freedomways" for the holidays.

Also enclosed was a letter on the stationery of JAMES BALDWIN and bearing the signature, JAMES BALDWIN. This letter states that he was renewing his subscription to "Freedomways" for two years and that, out of respect for the children killed in Birmingham, subscriptions to the magazine were the only gifts he was giving this Christmas. He asks that the recipient of the letter join him in using an enclosed envelope to mail in a check for a subscription.

The flyer and letter described above are filed in the 1A Section of 100-144189.

D. Marital Status

An article in the June 3, 1963 issue of "The New York Times" indicates that subject has never been married.

E. Military Status

Subject registered with Selective Service, Local Board 11, 80 Lafayette Street, New York 13, New York, on September 17, 1948, and was assigned registration number 50-11-24-577. He was classified 1A on November 8, 1948, and on February 14, 1950, was classified 5A.

The subject was scheduled to take an Armed Forces examination in New York City on December 14, 1948. However, this examination was not taken due to subject's residence in Paris, France.

Subject is not known to have ever served in the Armed Forces of the United States.

F. Credit

However, his only interest was writing, and in 1945 a Eugene Saxton Fellowship enabled him to devote himself to literary work.

This communication reflected that a delegation of Southern integration leaders would, on that date, take petitions signed by over 1800 leaders in the field of human rights, representing all 50 states of the United States, to President KENNEDY, asking him to free CARL BRADEN of Louisville, Kentucky. Among those listed as signers of the petitions from New York State was JAMES BALDWIN.

Concerning CARL BRADEN, it is noted that ALBERTA AHEARN, 2311 Payne Street, Louisville, Kentucky, a self-admitted former member of the Communist Party (CP) in Louisville, Kentucky, on December 11 and 13, 1954, in her testimony in Jefferson County, Kentucky Courthouse, in the prosecution of CARL BRADEN, testified that CARL BRADEN was known to her as a member of the CP in Louisville, Kentucky, from January, 1951, to December, 1954, which was during the period of her (AHEARN's) CP membership.

In testimony before the House Committee on Un-American Activities at Boston, Massachusetts, on March 18, 19 and 20, 1958, ARMANDO PENHA, a former member of the CP, identified DAVID LUBELL as a Communist Organizer among the students at various institutions of higher education in the Boston area. PENHA also identified DAVID LUBELL as a Harvard student who was an Organizer for the CP at the same time. This information is pertinent to the period 1952.

IV. STATEMENTS ATTRIBUTED TO  
JAMES BALDWIN

In an interview appearing in the June 3, 1963 issue of "The New York Times," by reporter N.S. HANDLER, BALDWIN made the following statements:

"No man can claim to speak for the Negro people today. There is no one with whom the white power structure can negotiate a deal that will bind the Negro people. There is, therefore, no possibility of a bargain whatsoever."

"I was raised in the church but have abandoned Christianity as an organized religion. The church is the worst place to learn about Christianity. I have rejected it because the Christians have rejected Christianity. It is too pious, too hypocritical."

In his interview with HANDLER, BALDWIN also stated that he could not accept the black Muslim political ideology based on black supremacy, but thought that the Muslims were the only grass roots Negro movement in the United States.

The June 3, 1963 issue of "The New York Times" contained another article on the subject in which he stated:

"I left the country and abandoned everything in 1948, never intending to return. I couldn't bear it any longer. I knew that I would kill somebody or someone would kill me. I lived in Paris and elsewhere in Europe long enough to vomit up most of my hatred and to place America in perspective.

"It was in Paris that I realized what my problem was. I was ashamed of being a Negro. I finally realized that I would retain what I was to the end of my time and lost my shame. I awoke from my nightmare."

On May 29, 1963, NY T-9 advised that on May 28, 1963, JAMES BALDWIN addressed a rally sponsored by the Staten Island Chapter of the Congress of Racial Equality (CORE), which rally was held at Wagner College, Grimes Hill, Staten Island, New York.

At this rally, BALDWIN stated he was speaking as an individual Negro rather than as spokesman for the Negro. He gave a brief outline of his boyhood in the South. The theme of his talk was that integration in the South is the problem of the white man and not of the Negro. He said it was not a Southern problem but a national problem. BALDWIN said he was not interested in compromises for the Negro, stating that compromising was a way of evading responsibility.
