The records of the New York Secretary of State, Albany, New York, show that the certificate of incorporation of Freedomways Associates, Incorporated, was filed on March 2, 1961.

The Spring, 1963, issue of "Freedomways" is self-described as "A Quarterly Review of the Negro Freedom Movement" published by Freedomways Associates, Incorporated, 799 Broadway, New York City.

On May 24, 1961, a source advised that a report was given on "Freedomways" at a meeting of the National Board, Communist Party, USA (CPUSA), held on May 24, 1961. It was stated that the original plan called for the publication to be openly Marxist, but that it was later decided it would not be avowedly a Marxist publication. Editorials are in the hands of a mixed group of Marxists and non-Marxists. It was stated that the central purpose of "Freedomways" is to develop a theory and positive criticism of currents in the Negro movement, as well as to raise the level of understanding and discussion taking place in Negro life today and to project a socialist and pro-Soviet orientation.

On May 25, 1961, another source advised that "Freedomways" was set up for the CPUSA by James Jackson, a member of the National Committee of the CPUSA.

The above sources have furnished reliable information in the past.

At 4:40 PM, 12/9/63, Inspector J. A. SIZOO called from the Bureau and instructed the NYO to immediately prepare an investigative report, suitable for dissemination, on the captioned individual. BALDWIN is the well-known Negro author and during recent months has been active in certain integration activities.

Mr. SIZ00 said that sometime during recent months BALDWIN is reported to have made a statement to the effect that he would not fight for this country. The fact that BALDWIN made such a statement has come to the attention of the Attorney General.

Mr. SIZOQ said that at the time we submit this report to the Bureau, we should also submit our recommendation for including BALDWIN on either the Security Index or the Reserve Index. Mr. SIZOO said that in the event the NYO does not feel we can justify recommending him for the Security Index, we should at least recommend him for the Reserve Index as the Bureau definitely feels this action is warranted on the basis of information presently available concerning BALDWIN.



"increasing liaison with SCEF, SNIC, and other organizations, the building up of Congressional District committees, and initiating new service groups.

"He outlined the NCAHUAC strategy for the period between now and January 1965, during which the appropriation for HUAC will come up in January 1964. It is apparent, he said, that the HUAC will press for more and more legislation based on the McCarran ACT.

"The National Committee will prepare reprints of an article by HENRY STRELE COMMANGER which appeared in the New York Times, on the First Ammendment right of travel. The new National pamphlet will document the fact that the HUAC is led by segregationists, and racists, and harries people who are working for integration.

"The Secretary described a meeting at American University, in Washington, D.C. during which 15 fights and arrests took place, and when the Secretary was physically attacked on the platform. The students had an opportunity to see the danger of fascism in action, but the actions of the Nazis in breaking up the meeting resulted in a decision to close future meetings at the University to the public

"The numerous meetings at other colleges and universities were successful, although ultra-rightists and Bircher elements were well represented. The many rough questions were successfully handled by the Secretary, as evidenced by student applause, and invitations to return to speak at future meetings.

"The Secretary feels that attitudes are changing around the country, but that it will be impossible to have integration and civil liberties until the HUAC is abolished.



CITIZENS COMMITTEE TO PRESERVE AMERICAN FREEDOMS

The "Guide to Subversive Organizations", revised, December 1, 1961, pp.43-44, describes this committee as follows:

"The Citizens Committee to Preserve American Freedoms * * * specializes in propaganda aimed at abolishing the Committee on Un-American Activities and discrediting the Federal Bureau of Investigation. Created in Los Angeles in 1952, the front organization is run by FRANK WILKINSON, an identified Communist who recently resumed the full-time, paid post of executive secretary after approximately a year's leave of absence to assist in a similar campaign by another front in New York City, the Emergency Civil Liberties Committee.

"When the Committee on Un-American Activities held hearings in Los Angeles, September 2-5, 1958, to inquire into the nature of the Party's recent reorganization in California, the Citizens Committee to Preserve American Freedoms sponsored a series of public meetings to protest the hearings and the very existence of the Committee. Communists subpoenaed as witnesses were guests of honor.

"At this time, leaders of the party's Southern California District, were mobilizing Communists in the area for participation in an intensified campaign to abolish this committee of Congress. How the Citizens Committee to Preserve American Freedoms served the party in this effort was revealed by (Communist Party) District Chairman DOROTHY HEALEY in a report to the party's Southern California District Council on September 21, 1958. Mrs. HEALEY declared that the party preferred public protest meetings to be held by the Citizens Committee to Preserve American Freedoms rather than under party auspices because Communists could attend without danger of being exposed as members of the party. She also noted that Communists scheduled as congressional committee witnesses could not appear beforehand at openly Communist rallies without creating the impression that the party was conspiring with witnesses to withhold information from the committee."



According to the same source O'DELD later on the same date contacted CLARENCE JONES and discussed with him a stolen typewriterrand asked JONES advise. He stated that IBM had a Marshall's Warrant of Levy and Sale under which they could sell "our furniture" unless "we" pay for the stolen typewriter.

On 11/29/63, advised that on that date a DAVE (LNU) contacted O'DELL and stated that he intended to pick up JIM (LNU) and then come by JACK O'DELL's place in 45 minutes to get him and that they would then drive to La Guardia Airport.

Subsequently on the same date, JAMESARBLDWIN placed a call from O'DELL's residence to Howard University in Washington, DC and asked to speak to JOHN LEWIS or JAMES FORMAN or whoever was in charge of the Student Non-Violent Co-Ordinating Committee conference that morning. BALDWIN identified himself as JAMES BALDWIN and asked that the call be charged to his number, TR 7-7773.

BALDWIN placed a call and told an unidentified male that he was in New York but that they were grounded and that the first plane he could get would be one at 11:30 am. He stated that they would arrive in washington about 12:30 pm and then introduced







The June 3, 1953 issue of "The New York Times" contained enother article on the subject in which he stated:

"I loft the country and abandoned everything in 1948, never intending to return. I couldn't bear it any longer. I knew that I would kill somebody or someone would kill me. I lived in Paris and elsewhere in Europe long enough to vomit up most of my haired and to place America in perspective.

"It was in Paris that I realized what my problem was. I was ashaned of being a Negro. I finally realized that I would remain what I was to the end of my time and lost my shame. I amoke from my nightware."

On May 29, 1963, NY T-7 advised that on May 28, 1963, JAMES HALDHEN addressed a rally sponsored by the Staten Island Chapter of the Congress of Pacial Equality (CORE), which rally was held at Magner College, Orimes Hill, Staten Island, Hest York.
